### How Do Wine Futures Work?

Tyrrell's Wine Futures allow the customer to purchase one or more wine options at 50% of the wines value.

Tyrrell's will cellar this wine for a minimum of four years. Upon maturation of the wine option, Tyrrell's will contact the Option holder and present the following choices:

- Take possession of the cellared wine after payment of the remaining 50% (the price being fixed four years earlier.)
- Redeem the initial investment at approx 4.5% compound interest or \$29 per dozen.

### How to order

Simply complete the application form in this brochure and return it together with an amount to cover the value of the Option you wish to take.

### Conditions of offer

Each Tyrrell's 2010 Heathcote Shiraz Futures Option entitles the registered holder to either purchase the reserved wine in March 2015 by paying the balance of \$148 per dozen, or cash in the Option to Tyrrell's Vineyards Pty Ltd for \$177 per dozen at that time. Tyrrell's Vineyards Pty Ltd will ensure that the reserved wine is held under temperature controlled conditions and will notify the Option holder at their registered address at the time of maturity.

All title and risks in the reserved wine remains with Tyrrell's Vineyards until delivery.
