

..... **CSR for our Environment**

- Tyrrell's maintains an Environmental Management System designed to comply with all of the requirements of the International Standard for Environmental Management, ISO 14,000.
- Our EMS includes monitoring and reporting systems that allow us to calculate and record our environmental performance annually, in order to measure progress towards the achievement of our environmental objectives and targets.
- Tyrrell's operates a program of continual improvement for Energy Reduction, with energy reduction initiatives such as Solar Power, more efficient cooling systems, heat reflective paint and variable speed refrigeration pumps being implemented since 2009.
- We operate a highly effective Recycling Program, for recycling of all packaging wastes, glass, paper, cardboard, waste oil and grape marc, which are all collected, segregated, and recycled in order to avoid disposal as landfill. Even our winery wastewater is treated, clarified and recycled back out as irrigation water for our surrounding paddocks.
- Our viticulture practices are highly sustainable, with use of organic mulches and manures and recycling of grapevine waste, predominantly dry-grown grapevines (non-irrigated), and retention of natural pasture and woodlots. Evidence of our successful sustainability practices can be seen in the continued production of wine from some of our iconic vineyards that are now well over 100 years old.
